## **9. Conflicts of interest**

## **10. Legal framework**

All contractual and business relationships between MGW mbH and its business partners are subject exclusively to German law, to the explicit exclusion of the UN Convention on Contracts for the International Sale of Goods. To the extent legally possible, jurisdiction shall lie with the courts where MGW mbH has its registered office. The contract language is German. Insofar as business communication must be conducted in a different language than German, German law shall be nonetheless exclusively applicable. Business partners may communicate with MGW mbH by telephone, in writing or electronically (letter, fax, e-mail, Bloomberg, Reuters).

## **11. Clients**

In the business of brokering financial instruments (fixed income segment), MGW mbH classifies its clients in accordance with Section 67 WpHG and only accepts eligible counterparties and – in individual cases, after review – professional clients, as business partners.
